This year in addition to our fundraising events, we have been lucky enough to secure some funding from local business John Lewis which allowed us to purchase a new oven and hob for the small kitchen in the Hall. We have also funded a new projector for the school hall, musical instruments, coaches to the pantomime, workshops and external performances, ice lollies and the year 6 leavers treat.

As you may know, Katie and Marina are standing down as Chairs with Faye becoming sole Chairperson. Sarah Curtis will also be stepping down as Treasurer. Sarah has been invaluable at bringing the LSA accounts all online and we will miss her very much.

We would like to say a huge thank you to the Class reps, who do such a brilliant job at sending out communications to parents and encouraging them to take part in our events. Thank you for all you

do. I would also like to say a special thank you to Mrs Boylan, who has been so supportive for all the LSA events, it's so appreciated. Finally, we would like to express our huge thanks to all the parents and staff who gave their time and effort to make these events happen. Without everyone's hard work these events could not take place. Every contribution is very much appreciated, however small.

4) Treasurers Report

The LSA had another successful year of fundraising with circa £13.5k of income achieved (compared to £14.2k last year). This is a great achievement as the income from the fete, our largest fundraiser of the year, was half that of the previous year due to very unkind weather!

The reduction of ~£3.5k in fete income was offset by an increase of ~£1k in fireworks profits, an extremely generous parent donation of £2k and a £750 donation secured by one of our Co-Chairs (Faye Dave) from John Lewis to go towards buying a new oven & hob for our hall kitchen.

The purchase of a SumUp card reader is moving the LSA away from being reliant on cash.

It was highlighted that as intended, the income and outgoing figures were very similar this year (i.e. the income generated by the families of the children during the financial year was spent on those children). It was also mentioned that if we are to follow this trend in future years, we may want to think about what we want to do with the end of year bank balance as it isn't an insignificant amount.

The appointed Auditor for the last academic year (Carrie Shannon) has reviewed the accounts for the period.

Expenditure: £12,980.28
Income: £13,504.40
End of Year Balance: £8,739.11

The Committee approved the above income and expenditure figures for submission to the Charity Commission for the financial period ending 31st August 2024.

10) Constitution

SC proposed the following changes to the Constitution to allow for the aligning of the financial and school year ends and the number of accounts now being managed, as well as tidying up the list of Committee Members (the Head covers the Member of Staff role):

3. Committee Members

The Committee shall consist of the following Association Members:

- Head Teacher
- Member of staff
- Chair er/ Co-Chairs
- Secretary
- Treasurer
- Class Reps (a minimum of 7, covering each of the school years)
- Governors Liaison

The Chair(s), Secretary, Treasurer, and Class Reps and Governors Liaison shall be elected at the Annual General Meeting (AGM).

6.1 Annual General Meeting (AGM)

An AGM shall be held every year in September. At least 14 day's notice shall be given to all Members. The agenda for the AGM shall be:

- Welcome new Members to the Association
- Review the Head Teacher, Chair and Treasurers Reports covering the previous school year
- Review & approve the accounts for the previous reporting year (to end June) and school financial
 year (to end August)
- Approve the accounts for the latest reporting year for submission by the Treasurer to the Charity Commission
- Elect Committee Members for the new school year
- Elect an Auditor for the new school year
- Review and approve the Trustees of the Charity
- Review and approve the signatories on the LSA bank accounts
- Review and approve the LSA Constitution (this document)
- Any other business

7. Financial Arrangements

ABbank Aaccounts shall be operated in the name of the Association.

Signatories on the account shall be the Treasurer, the Chair (or one of the Co-Chairs), and any two other Parent Members. The Treasurer shall be the main contact on the aAccounts.
